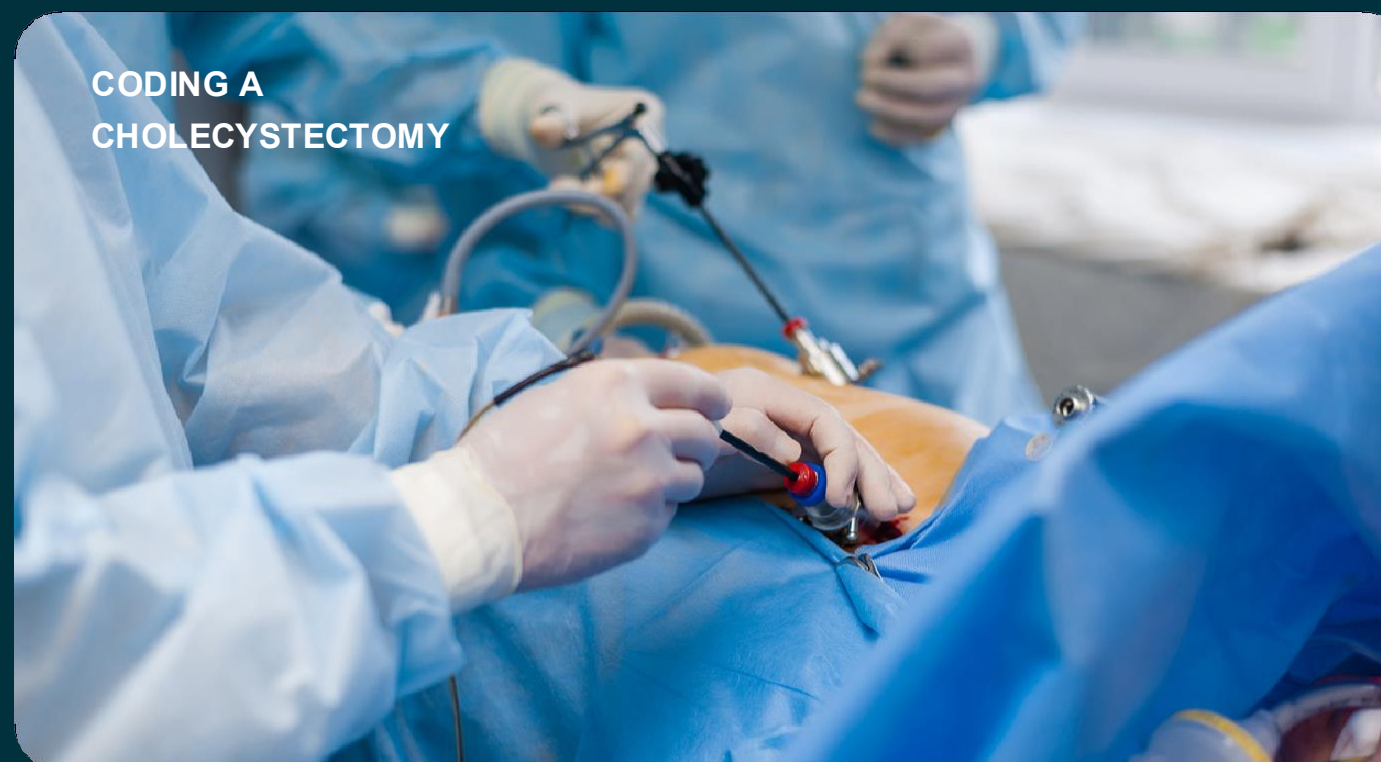

## Coding an Injury as a Result of a Fall: A Trauma Case Workshop

This workshop reviews your knowledge on coding injuries because of a fall using the source documents and verifying the coding rules with the CIHI Coding Standards. The ability to accurately interpret the source documents and locate the appropriate codes is critical to ensure high-quality data. Participants of this workshop will be able to review history, physical examination, operative, and radiology notes to consider how they would code this chart. From there, Kim Durofil, CHIM, BHA, presents the appropriate codes and explanations will be given to verify the answers.



## Excel PivotTables, Dashboards and Advanced Chart Features

## Cultures' Impact on Privacy Practices

In a healthcare setting, professionals working in trustee or custodian-run facilities will interact with people from all walks of life with different perspectives and expectations based, at least in part, on their cultural backgrounds and experiences. In the case of providing health services, these differences must be respected, but privacy laws must be adhered. This session will focus on how to achieve both goals.



## Privacy Management Programs – A Key Tool for Compliance

A Privacy Management Program (PMP) defines how your organization will manage its unique privacy risks and meet its compliance obligations under privacy laws and regulations. Some laws are moving PMPs from best practice to a mandatory requirement. PMPs are generally structured into three core components: foundation and governance, privacy program controls, and ongoing assessment and improvement.

## Zeroing in on Z-Codes

This education session will focus on the accurate diagnosis code assignment for Z codes for Admission for Observation, Follow-up Examination, Convalescence, and Screening for Specific Diseases. A concise description of each code will be given and the logic and rationale behind code assignment will be demonstrated. Example cases will be provided with interactive polling questions for HIM professionals to test their knowledge. Following completion of the session, attendees will be able to accurately define and contrast the above Z codes and apply logical steps to arrive at the correct diagnosis code assignment.



## Traumatic Injuries and Post-Intervention Conditions: An External Cause Codes Session

Focused on appropriate external cause code selection, traumatic injuries and post-intervention conditions: An external cause codes session, takes one through various coding definitions, tools, resources, and relevant thought exercises for traumatic injuries (transport accidents & falls) and post-intervention conditions. It includes a documentation hierarchy, post-intervention condition description and differentiation. This session started as a working group via the CHIMA BCYT chapter and is a resource for experienced coders.



## Workshop: Let's Brush Up on Alternative Level of Care

We will review a medical chart using the Canadian Coding Standards and ICD-10-CA/CCI, focusing primarily on the Alternative Level of Care (ALC) component due to time constraints. We'll examine coding variances together and work toward a general consensus. All codes will be available afterward for you and your team to review your performance.



## Coding a Cholecystectomy

This workshop will review your knowledge using documents on a surgical case. By the end of the workshop, you will have covered the coding standards pertaining to:

- Acute and chronic conditions
- Pre-admit comorbidities versus secondary
- Laparoscopic versus open approach
- Mandatory attributes when not "pink"



## Excelling Shoulder Coding: A Workshop with Essential Tips

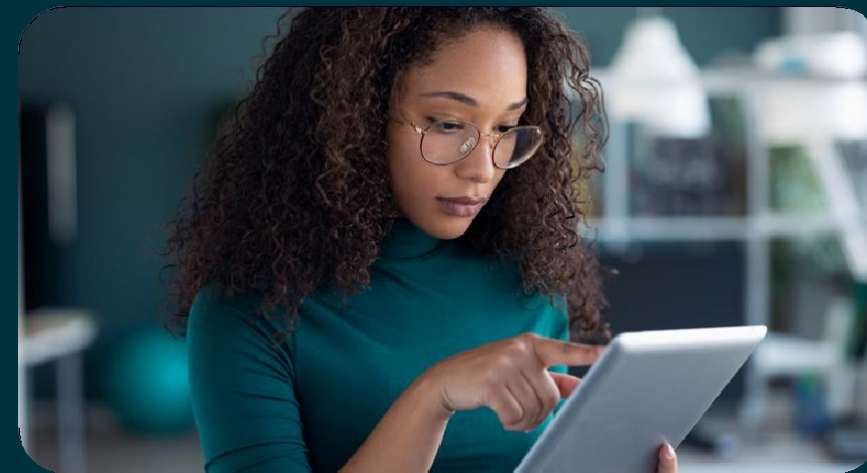

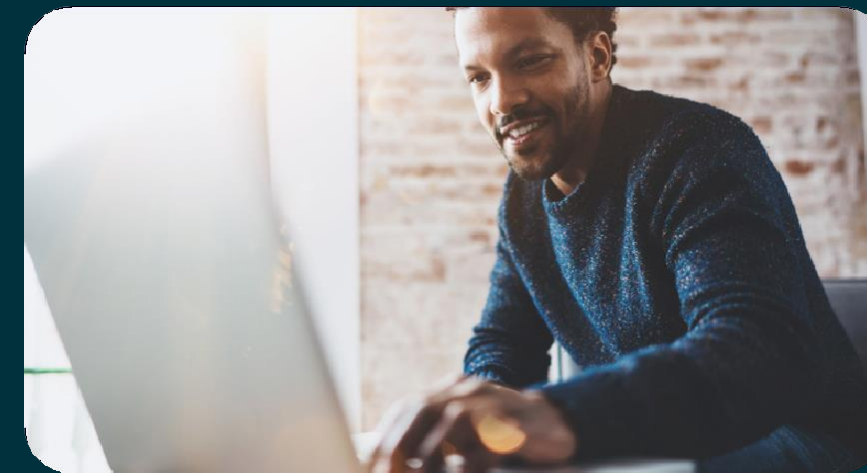
